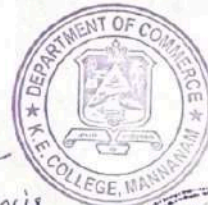

2. INTENTION OF THE PARTIES

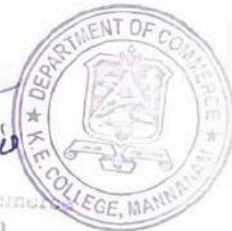
2.1 Work together in good faith to examine and determine the feasibility of pursuing the Project in relation to the areas: -

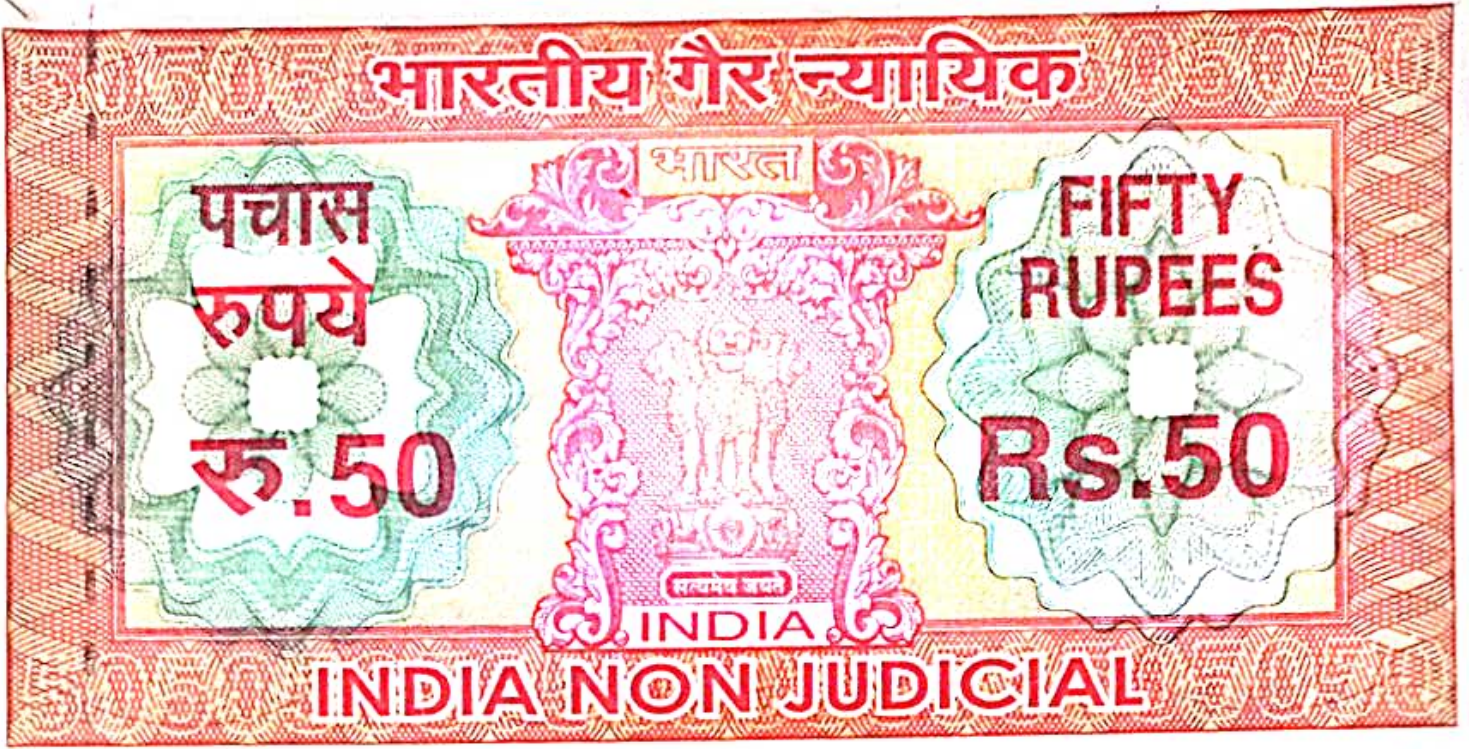

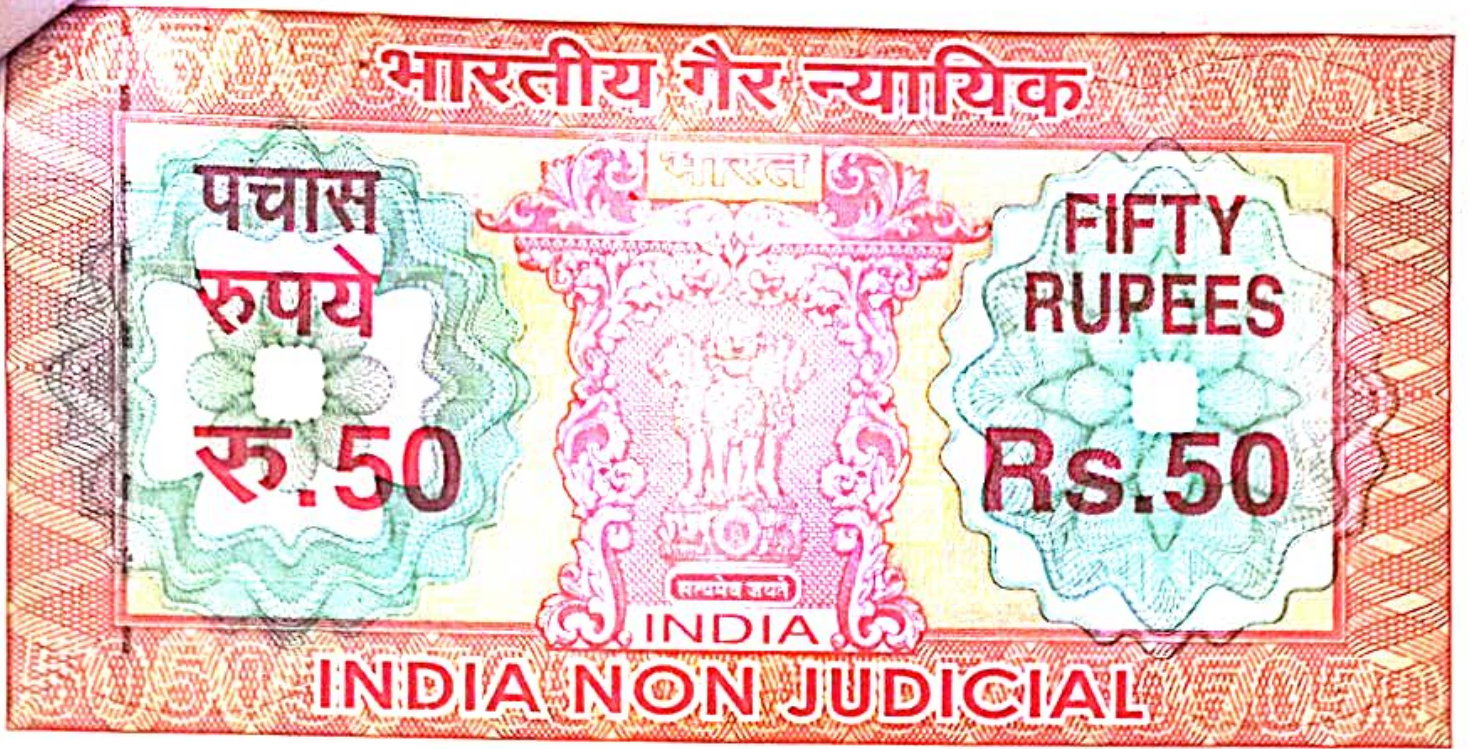

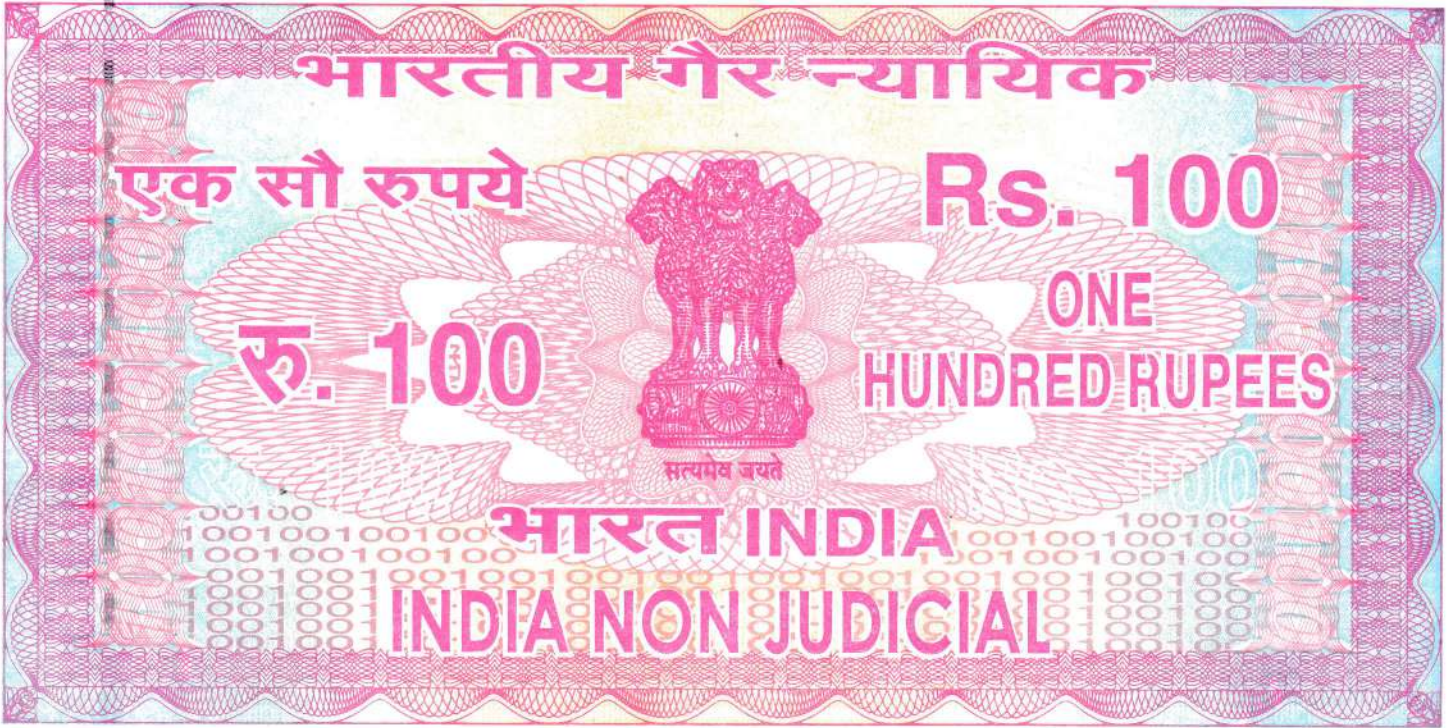

It is funded by Kerala Startup Mission (KSUM).

PRIMARY OBJECTIVES

1. To enhance skills of students/aspirants through internship and vocational training.
2. To be quality skill enhancement partner and projects/system integrator for corporate and government agencies.
3. Working closely with industry for establishing the curriculum as per its requirements and also with academia in order to enhance the quality of education in the country.
4. Playing an effective role in the ongoing Govt. initiative on "Skill Development Mission" with a view to contribute to the overall target of skilling/upskilling 500 million people in India.



SCOPE OF COOPERATION

Role of First Party:

1. The First Party agrees to conduct various skill development, vocational & job-oriented training programs on the campus of the Second Party and use their classroom, lecture halls/auditorium for managing training programs.
2. The First Party agrees to provide certification for all the joint training courses that may be organised with the Second Party which will be under the Direct Supervision of the First Party only after receiving the complete details of the trainees from the Second Party and completing the Evaluation / Assessment Criteria.
3. The First Party will design the course curriculum for the courses to be conducted therein and to be finalized jointly with the Second Party. The First Party will maintain high standards and update the course contents to bring new development in the training/ subject field as and when required for training and for transfer of know-how.
4. That the Selection of appropriate training programmes, arranging resource persons for training, course design, co-ordination, conduct and evaluation of trainings will be done jointly by both the parties.
5. That the fee structure recommended in **Annexure I** be reviewed and revised jointly by both parties as and when necessary in light of the then-current circumstances.
6. That the provision of resource materials – teaching notes, course material and relevant software required for the program delivery by First Party or Second Party as the case may be shall be decided based on the nature of training that is mutually convenient to both, on case to case basis.
7. That it is further agreed that Expenditures on honorarium payments to external faculty/ resource persons and all other incidental expenses like publicity, and stationery items will be incurred by the First Party itself for the training programmes jointly organised by both the parties.
8. The First Party will not bear any cost towards maintenance / break down / damage of equipment at the Second Party.
9. The First Party agrees to pay the Second Party the amount specified in **Annexure I** towards providing their classrooms, lecture halls / auditoriums, and lab facilities with a suitable Public Addressing System.



Role of Second Party:

1. The Second Party agrees to provide 20 Nos of Computer Systems, Printers, UPS and other related equipment, requisite software as per the configuration, along with power conditioning equipment and auxiliary power equipment and shall equip the Class Rooms, Laboratory, Faculty Room, with infrastructure facilities like Furniture, White Board, OHP, Video Projector (DLP/LCD), electricity, thereby creating a conducive learning environment.
2. That it has been agreed that the Second Party will facilitate the registration of participants and provide the list of participants who have signed up for the courses along with the relevant documents before commencing the programme.
3. That it has been agreed that whereas appropriate course fee per participants will be fixed jointly by both the parties. Participants will either do NEFT or bank deposit, the course fee directly into the First Party's bank account.
4. That it is further agreed that the Second party will not accept any cash payment from participants and will collect only scanned copy of deposit slip on behalf of First Party from participants in the name of First Party.
5. That it has been agreed that the Second Party will only use the pre-approved template provided by the First Party for the purposes of marketing the programme in all forums, including Electronic Media, Print Media, and Social Media Platforms, or any other mode of advertisement.
6. The Second Party will nominate the Coordinating/ Liaison Officer for communication and coordination with the First Party.
7. That is mutually decided that Classes will be conducted during working hours or evening hours (post 4pm), Monday to Friday, and if required during the weekends or weekdays, as mutually agreed between the parties herein.
8. It is jointly agreed that the Second Party shall raise an invoice within a week of the commencement of the training programme in the name of the First Party which shall then review it and clear the same and make arrangements to pay the Second Party if the same is in order and there is no discrepancy within 30 days of its receipt.

GENREAL PROVISIONS


- I. **Validity of Agreement:** This MOU shall be valid for a period of 11 months commencing from the date of signing of this MOU and which can be further extended by mutual consent of both the parties in writing.
- II. **Resolution of dispute:** Any dispute between the parties arising in connection with the performance of this MoU shall be resolved amicably between the parties through a process of negotiation by the representatives of both the parties.
- III. **Termination:** Withdrawal / cancellation / discontinuation of MOU shall be by way of serving prior notice of one month either party. Such notice shall not have adverse effect on duration / completion of course, in which the trainees have already been admitted.
- IV. **Severability:** The construction, interpretation and enforcement of the MoU shall be governed by the present judicial laws available. Should any portion of this MoU be judicially determined to be illegal or unenforceable, the remainder of the MoU shall continue in full force and effect, and either party may re-negotiate the terms affected by the severance.
- V. **Limitation:** No rights or limitation shall arise or be assumed between the Parties as a result of the terms of this MoU.
- VI. **Amendments:** Each party may request changes to this MoU. Any revisions which are mutually agreed upon by the parties to this MoU shall be incorporated in a written instrument. The amended agreement shall take effect when executed and signed by all parties of this MoU.
- VII. **Use of Name, Logo or Official Emblem:** Both parties mutually agree not to use, publish, distribute, display or reproduce the name, logo and/or official emblem of either party in any manner, context or format (including references on or links to websites, in press releases, or in other public announcements) without the prior written approval of the concerned party.



VIII. Miscellaneous: It is expressly agreed that First Party and Second Party are acting under this MoU as independent entities, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

It is intended that the partners remain independent of each other and that their collaboration and use of the term ‘partner’ does not constitute the creation of a legal entity, nor authorise the entry into a commitment for or on behalf of each other.

1. Background

- 1.1 From the Heart: Testing the Efficacy of Heart-Centered Contemplation (hereafter *From the Heart*) is a project housed at Coventry University UK funded by Templeton World Charity Foundation
- 1.2 The project is led by Dr Miguel Farias and Dr Inti Brazil (Radboud University) with PhD student Faye Ng and the trial coordinator Jyotsna Joseph leading on delivery of the primary project output (hereafter collectively referred to as *the Project Team*).
- 1.3 The primary project output is a Randomized Controlled Trial (RCT) comparing the efficacy of two contemplative exercises, from the Christian and Islamic traditions, with an active control and waitlist conditions, via a phone App throughout 8 weeks. This will be undertaken with a sample of 288 participants (including 144 who will be practicing Christians who take part in mass at least 2 times per month, and who pray at least weekly). Psychophysiological, cognitive, social functioning, and self-report outcomes— including heart rate variability, pain tolerance, attention, prosociality, forgiveness, stress, anxiety, and depression – will be assessed at 3 time points: right before the

intervention, 8 weeks afterwards, and at a 3-month follow up after the intervention ends. In addition to assessing these outcomes, we will test stress level, affect, and perspective taking as potential mechanisms of change. In accordance with Open Science principles, we will pre-register the study at clinicaltrials.gov (ID NCT06136676), make the datasets publicly available, and follow CONSORT guidelines for medical randomized controlled trials. Ethics permission for this study has been granted by Coventry University (P137113) and Institutional Review Board (IRB) of KE College, and follows European Union established General Data Protection (GDPR) guidelines of participant confidentiality, anonymity, data protection, and the right to withdraw from the study.

1.4 The Project Team and Kuriakose Elias College (KEC) have formed this partnership to complete a proportion of the trial with Christian participants in Mannanam, Kottayam, Kerala, India.

1.5 It is an equal partnership for the mutual benefit of both parties.

1.6 For the Project Team, the partnership offers an opportunity to pursue research that promotes greater inclusivity and decenters Western-centric experiences and perspectives. For the Kuriakose Elias College, the partnership provides co-authorship opportunities for participating academics from the Psychology Department, and opportunities for early career researchers and recent graduates to gain experience as Research Assistants (RAs) on a RCT.

2. Partnership aims

2.1 The overarching aim of this partnership is to successfully complete part of the RCT in Mannanam, India.

2.2 Specific objectives are to:

- 2.2.1 Recruit and train local Research Assistants
- 2.2.2 Recruit participants for the trial
- 2.2.3 Complete the trial with the student participants
- 2.2.4 Produce publications and other outputs from the data

3. Partnership activities

3.1 Activities to be delivered by the partnership are:

3.2 Project team activities

- 3.2.1 To provide a clear brief on requirements for local RAs and local facilities.
- 3.2.2 To provide all necessary background documentation on the design and method of the RTC.
- 3.2.3 To be physically present on campus to deliver training to the RAs.
- 3.2.4 To set clear expectations around how data needs to be stored and transferred.
- 3.2.5 To provide support and guidance to the RAs as needed.
- 3.2.6 To provide a clear and efficient process for payments to RAs and participants.
- 3.2.7 To provide draft publications to participating colleagues at other institutions for their input and review.

4. Kuriakose Elias College activities

- 4.1.1 For Kuriakose Elias College to recruit 2 local Research Assistants and one Department Trial Coordinator from the department of Psychology. The RAs will need to be set up to be paid through the institution and will need access to things like email, workspace and facilities. Responsibilities of RAs include: Participant Recruitment, Testing Participants, Contact Participants, Booking Testing Sessions, Follow-Up with Participants, getting ethical clearance from the IRB of KEC.
- 4.1.2 To arrange access to 2 rooms with WIFI on campus that can be used for training and for testing sessions. The RAs will need sole use of the 2 rooms for the duration of the trial (access 8am to 10pm). The rooms should have wifi access and electrical outputs and one (in total) lockable space to store confidential documents and equipment such as laptops and heartrate sensors.
- 4.1.3 For the RAs, supported by the Project Team to recruit 144 Christian participants who meet the eligibility criteria for the RTC.
- 4.1.4 For the RAs, supported by the Project Team to complete the RTC with the participants: conducting tests gathering, storing and transferring data as set out by the Project Team, and stay in in touch with participants as needs be to minimize drop outs.
- 4.1.5 For participating colleagues from the Psychology Department at KEC to respond in a timely manner to draft publications provided by the Project Team for input and review.

3. Monitoring & Communications

4.1 To ensure accountability and realization of the partnership aims, all partners commit to meeting online as and when required. Meetings can be called by either party.

5. Designated partnership leads

- 5.1 Each partner will appoint a senior member of staff to lead on the work of the partnership.
- 5.2 The designated lead member of staff for each partner will be:

- 5.2.1 Miguel Farias, Associate Professor, Coventry University, UK
- 5.2.2 Johnson Joseph, Head of Psychology Department, Kuriakose Elias College, India

6. Financial contributions


- 6.1 The Project Team intends to facilitate a financial contribution to Kuriakose Elias College to enable them to complete their agreed activities under the partnership.
- 6.2 Research Assistants and Departmental Trial coordinator will be paid a salary of 25,510 Indian Rupees per-month for 6 months through Kuriakose Elias College
- 6.3 Kuriakose Elias College will be offered an honorarium of 1,000 British Pounds to compensate for various expenses, such as electricity and WIFI.
- 6.4 The participating students will be compensated with a voucher of up to 2000 Indian Rupees for their time.

2.4 Confidentiality: Each party agrees that it shall not, at any time, after executing the activities of this MOU, disclose any information in relation to these activities.



MEMORANDUM OF UNDERSTANDING

5. CSIP will allow a discount of 5% in fees for students and alumni of KEC for CSIP's Add-on Courses and Full-time courses on producing a letter of recommendation from the Principal of KEC. (This discount will be allowed if the candidate is not otherwise eligible for any other discount in fee for the courses of CSIP.)




Other Terms and Conditions


WHEREAS the Parties, agree to take part in the joint research initiatives in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both RGCB and KEC acknowledges. Thereby RGCB and KEC agree to the following protocols governing their collaboration and to sign a Memorandum of Understanding (MoU).

ARTICLE-I: SCOPE


The Scope of collaboration on academic and research activities in this Memorandum of Understanding includes the sharing of facilities of RGCB to KEC and vice versa for the training and/ or conducting collaborative research of the staff, students and research fellows.

ARTICLE-II: TERMS OF INTERACTIONS

1. The parties agree to take part in the joint research initiatives and also for collaboration whereby faculty, students and staff of the Parties will join hands in carrying out the research activities approved by the Director of RGCB and the Principal of KEC.
2. The duration, frequency, adequacy and modalities of various programs will be decided on mutual consent.
3. The parties will provide intellectual and infrastructure support for carrying out academic research and training in collaboration in the areas of mutual interest.
4. Mutually approved academic training/ research will be executed without any financial liabilities on each other for recurring expenses after assessing the priority. The outcomes of the studies in terms of research papers, will be jointly shared by the individuals from the parties and sharing of patents, products, etc. will be in accordance with separate agreements entered into for such purpose.
5. The parties shall jointly submit proposal for funding for the research. The allocation and management of research grants/funds will be decided upon by both parties, prior to submission of funding application to research funding agencies/organizations, and which will be agreed by mutual consensus.

6. RGCB will coordinate KEC with other R&D institutes in India like CSIR-NIIST, IISER and the like to achieve the goals envisaged under this MoU.

7. Such other programs acceptable to both parties.

8. The Parties anticipate that the general academic exchange contemplated by this MoU will lead to the development of specific projects, each of which may have academic, clinical and commercial implications. Each specific project will be governed by a separate Agreement that will set out in detail the complete responsibilities and commitments of each Party for the specific project. The Parties acknowledge and agree, however, that this MoU does not obligate them to enter into any further Agreement.

ARTICLE-III: SHARING OF FACILITIES

- a) RGCB and KEC shall make provisions to share their respective major R&D facilities in order to carry out the research projects.
- b) RGCB and KEC shall permit sharing facilities in their premises required to carry out the research projects, if permissible within the rules governing the two organizations.
- c) RGCB and KEC shall provide access to the library facilities to personnel of both the organizations involved in the project as per the applicable rules and norms.
- d) RGCB and KEC shall on mutually agreed terms arrange and coordinate Resource. persons/faculty for the academic activities including orientation programs, workshops and lectures.

Article IV: Responsibility for Costs


4.1 Students/Faculty exchange: Unless otherwise agreed upon in writing for some particular case, expenses like traveling, stay, food etc. will be borne by the visitor's own institute as per their rules.

4.2 Generally: Each party will be responsible for its own costs and expenses in connection with the activities contemplated by this MoU, unless and until they enter into a separate specific project Agreement.

4.3 Facility Charges: Each party will be responsible for its own costs and expenses in connection with the Central/Institutional Facility usage charges if any, contemplated by this MoU.

Article V: Term of MoU

This MoU will become effective from the date when the signatories representing both institutions have affixed their signatures to it, and shall be valid for a period of three (3) years from the date of signing the MoU. The term of the MoU can be terminated by the parties before the term as apprehended above by providing a notice of 60 days prior before the proposed termination date to the other party. In such cases the ongoing activities shall be completed within the time period allotted.

ARTICLE-VI: IPR

- a. Any intellectual property rights patents/design/trademark/copyrights /know-how obtained by the PARTIES hereto pertaining to this joint research initiative prior to signing of this agreement shall remain the property of respective PARTY.
- b. Rights regarding publications, know-hows, patents, royalty, ownership of software/design/product developed etc. under the scope of this MoU shall be decided by the two parties by mutual consent. Each Party hereby acknowledges that the activities contemplated by this MoU may be subject to the laws of India.
- c. The intellectual property that is know-how/process/design/technique/patents/copyrights generated from and during the collaboration as contemplated in Article 2 clause 4 shall be jointly owned by the RGCB and KEC; the extent of ownership shall be decided mutually depending upon the relative inputs intellectual/technical/financial/physical/ made by the PARTIES hereto to the PROJECT.
- d. The procedural formalities for securing and maintaining the intellectual property rights (patents/trademark/copyright/industrial design) of Inventions shall be the joint responsibility of RGCB and KEC and the expenditure incurred shall be borne equally, provided, such intellectual property is jointly owned by the PARTIES and any revenues from such intellectual property are to be equally shared by the PARTIES.
- e. The question of whether or not intellectual property right should be secured and the territory where these shall be secured shall be decided with mutual consent, by Directors of both the parties. If a PARTY disagrees with the other PARTY's decision to secure rights to an intellectual property generated in the course of performing the collaboration and the other PARTY desires to pursue such intellectual property protection at its sole expense, the PARTY that does not participate in sharing the costs for the protection of such intellectual property will not have any rights to share revenues from such intellectual property in the territory where such PARTY has not shared the costs of protecting such intellectual property.

ARTICLE-VII: CONFIDENTIALITY

- a) During the tenancy of the MoU, both RGCB and KEC will maintain strict confidentiality and prevent disclosure of all the confidential information and data exchanged under the scope of this MoU for any purpose other than in accordance with this MoU.
- b) 'CONFIDENTIAL INFORMATION' shall mean any proprietary information, data or facts belonging to PARTIES collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions.

ARTICLE-VIII: AMENDMENTS

Any Article or clause of the MoU may be modified or amended by mutual agreement of RGCB and KEC. Any amendment or modification to this MoU shall be in writing and signed by both the parties hereto and shall only after such execution be deemed to form part of the MoU.

ARTICLE-IX: RESOLUTION OF DISPUTES

- a) This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of Courts at Thiruvananthapuram.
- b) If dispute or difference whatsoever arises between Parties in relation to or in connection with this MoU, both the parties shall first try to resolve the dispute/difference amicably between them, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation Act, 1996. The venue of arbitration shall be Thiruvananthapuram and the language of arbitration shall be English. The expenses for the Arbitration shall be shared equally.

ARTICLE-X: MISCELLANEOUS

The headings and sub-headings are inserted for convenience only and shall not affect the construction of this MoU.

- a) No failure to exercise and no delay in exercising, on the part of a Party, and right, remedy, power or privilege hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege. The rights, remedies, power and privileges herein provided are cumulative and not exclusive of any right, remedies, powers and privileges provided by law.
- b) After this MoU has been signed, all the preceding understandings/negotiations and the correspondence pertaining to it shall become null and void.
- c) EACH PARTY SHALL BE RESPONSIBLE FOR ITS NEGLIGENT ACTS OR OMISSIONS AND THE NEGLIGENT ACTS OR OMISSIONS OF ITS EMPLOYEES, OFFICERS, OR DIRECTORS, TO THE EXTENT ALLOWED BY LAW. EACH PARTY MAKES NO REPRESENTATIONS OR WARRANTIES.




PURPOSE

a) About KEC

c) About STC

St. Thomas College Palai, founded in 1950, is a minority educational institution affiliated to Mahatma Gandhi University, Kottayam, Kerala and included in section 2(f) and 12B of the UGC Act 1956. Located at Arunapuram in the Palai Municipality and Puliyanloor Village on a 28.58 acres green eco-friendly campus full of trees and plants on the banks of the river Meenachil, it has a conducive ambience for learning. In 2000, the college was accredited with 4 star by the NAAC during the first cycle of accreditation and with B++ grade (82.5% score) in the second cycle held in 2007. The college was re-accredited with A Grade (CGPA: 3.30) by the NAAC in 2015 during the third cycle and in February 2021, the college was re-accredited with A++ (CGPA: 3.56) Grade in the fourth cycle. The college was awarded with the CPE status by UGC in 2010 and was selected for the CPE Phase II in 2017. The college has been selected for the RUSA grant by the MHRD. The college has also applied for the autonomous status of the UGC. The college offers 18 UG, 15 PG and 10 Ph.D. Programmes. In addition, the college conducts a number of add-on, value-added and vocational education training programmes. The college has 2874 students including UG, PG and research, 140 faculty members out of which 41 are Ph.D. holders and 42 non-teaching staff. There are 46 recognized research guides in the college. The college also offers 55 endowments and 114 proficiency prizes. The college has a Students' union, with the office bearers elected through the parliamentary mode. The college has 14 clubs and 4 forums coordinating various students' activities. The college has an Anti-Ragging Committee for preventing the menace of ragging of all sorts. - j) Financial expenses for (term visits) internships of professors and researchers, which will be arranged at the parties' request, as well as travel expenses, shall be covered by the requesting institution. No fees will be paid, as the assumption is that the professors / researchers remain in their positions at their home institution, which will continue to pay their salaries.
- k) Students, professors and officers must acquire a medical insurance policy. The universities may offer them advice in seeking appropriate insurance.

5. NO EMPLOYMENT RELATIONSHIP:

 - xi. Financial budget;
 - xii. Reference to the subject of medical insurance and information.

Background and Purpose

Kuriakose Elias College, Mannanam has been established in the state of **Kerala** for Skilling youth to carry forward the skill development initiatives in a co-ordinated manner.

Whereas **IT-ITeS Sector Skills Council NASSCOM (SSC NASSCOM)**, the skill standard setting body of the IT-BPM Industry, is an integral part of NASSCOM in the education & skill development initiative. SSC NASSCOM works with its industry members and assist academic and skill development institutions to help improve the quality and quantity of the employable workforce available to this industry.

NASSCOM/SSC NASSCOM and KURIAKOSE ELIAS COLLEGE, MANNANAM and will hence forth be referred to independently as the 'First Party' and 'Second Party' respectively and collectively as the 'Parties'.

THIS MOU WITNESSED AND THE PARTIES HERETO AGREE TO AS FOLLOWS:

A. Objective

This MoU is for collaboration on the conduct of Assessments and Certification on Qualification Packs (QP) and National Occupational Standards (NOS) for Second Party sponsored candidates.

1. The **Objective** of this MoU is to showcase the employability skills of the candidates of the Second Party by their adoption of the National Occupational Standards (NOS), Assessments and Certifications developed by NSDC through its Sector Skill Councils. Under this MoU, First Party will ensure timely completion of assessment & its certification of candidates of the Second Party.
2. Currently 2 QP(s) for which candidates of the Second Party need to be assessed and to be conducted by the Assessment Bodies of the First Party, has been enclosed as **Annexure 1**. Going forward more QPs will be added in consultation with the First Party.

B. Role and Responsibilities of Second Party

The Second Party is the implementing organization and will be responsible for activities such as:

1. **Authorisation for Assessment & Certification of Second Party Candidates:** The Second Party will permit the First Party to conduct assessments and certify its candidates as per the defined QP(s), through Assessment Agencies empanelled by the First Party.
2. **Nodal Officer/Coordinator:** The Second Party will designate and recommend a Nodal Officer/Coordinator at Headquarters Level who will be responsible for overseeing/coordinating the program from Second Party which includes MIS & technical operations with the First Party.
3. **Payment Schedule to SSC NASSCOM:** The Second Party shall make 100% advance payment of assessment cost to NASSCOM/SSC NASSCOM i.e. the First Party, for all the batches for which the First Party shall give an acknowledgement of advance payment.
4. Assessment cost shall be paid on the basis of registered/scheduled number of candidates on SSC NASSCOM Portal (this covers those passed, failed and also covers absentees on the day of the assessment) subject to a minimum batch-size, which is 20 candidates per batch. The cost for an assessment and the subsequent certification will be as per the norms of NSDC & NASSCOM/SSC NASSCOM/First Party and currently is at INR. 800/- + all applicable Taxes (Taxes are over and above the assessment cost).
 - a. If a batch is not assessed due to Force Majeure or if informed by the Second Party at least 10 working days in advance to the date of the scheduled assessment or due to any other reason agreed upon by both the Parties, then the assessment will be carried out for the whole batch at a mutually convenient date. This communication between the Parties would be sent via E-Mail.

C. Role & Responsibility of the First Party

1. **Single Point of Contact (SPoC):** The First Party will designate and recommend a SPoC who will be responsible for the overall assessment related activities from the First Party.
2. **Student Assessment and Certification:** The First Party will organize the timely assessment and certification of second party candidates through empanelled 'Assessment Agencies' of the First Party. The First Party will issue certificates to the successful candidates via SSC NASSCOM Portal.
3. The First Party will raise an invoice against advance payment post conduct of assessment.
4. The First party via its Assessment Agency will be responsible for the fair and proper conduct of the QP assessment. Any issue(s) that arise regarding this will be amicably discussed between the First Party and the Second Party and resolved thereof.
5. Candidates will be assessed on the assessment criteria and question banks set by the First Party as per the respective QP concerned.

D. The below given operational processes will be followed for Assessment and Certification:

1. Second Party uploads its batch information in prescribed format on SSC NASSCOM Portal listing all details including the batch end date as required by SSC NASSCOM Portal.
2. Second Party must make the communication/request for the assessment date at least 2 weeks prior the batch assessment /training end date and the assessment date should be minimum 2 weeks post the payment date.
3. The Second Party will transfer the requisite assessment fees via the prescribed Payment Gateway of the First Party, as mentioned in Clause B, Sub clause (3) of this MoU.
4. First Party assigns the batch to its empaneled assessment agency for conduct of assessment.
5. Infrastructure details for conduct of assessment will be shared by the empaneled assessment agency to the Second Party while assessment confirmation is sent via Email.
6. On request from First Party the Second Party will furnish the candidate details of batch in excel format. The Second Party will be responsible for the accuracy of all the details provided in the Excel sheet and on SSC NASSCOM Portal.
7. Centre Manager/Centre Head of Second Party will sign a malpractice avoidance declaration form as detailed in Annexure-II (C) on the day of assessment and Second Party will make all efforts to avoid any malpractice at its assessment centres.

8. The First party will nominate proctors/invigilators to check the credentials of the candidates as detailed in Annexure-II (B) of this MoU.
